Applicant: Hawkeswood Mining Limited

Description of activity: Hawkeswood Mining Limited (the applicant), has applied to establish and operate an alluvial gold mining operation in a Rural Resource Area at 1346 – 1536 Teviot Road, Millers Flat, Roxburgh. The application is for a duration of 10 years and is assessed as a discretionary activity.

The total project area is 68 ha with the maximum volume of earthworks estimated to be approximately 12 million cubic metres. The depth of excavation varies across the site between 13m to 18m below ground level.

The mining activity will include on-site processing of gold-bearing wash using gravity and water separation methods. Overburden stockpiles up to 7m high will be located within the site for the duration of the activity.

Mining is proposed to operate Monday to Friday 7am – 7pm and Saturday 7am – 1pm with no earthworks or processing work occurring on Sundays or public holidays. Some machinery maintenance and dust control activities may occur on Saturday afternoons, Sundays and public holidays. Up to 20 staff will be employed on the project, and the site will be rehabilitated on completion of the mining activity.
