FUNDING ELIGIBILITY

Application for the rural travel fund is open to rural sports clubs and rural school teams with young people aged between 5-19 years who require subsidies to assist with transport expenses to local sporting competitions.

Funding is **not** provided for the purpose of travel to **regional** or **national** events.

CLOSING DATE

Applications for 2018/19 must be submitted by **Friday, 28 September 2018 before 4.00pm**.

UPLIFTING OF FUNDS

Applicants are advised that grants are to be uplifted by Friday 17 May 2019. Failure to uplift will result in the loss of the subsidy, which will be returned to the pool of funds for reallocating in the next funding round.

DOCUMENTATION

1. Applicants must provide all the documentation requested.
2. All applicants are required to submit a current financial statement and, if successful, will be required to provide evidence of the cost of the travel for which the subsidy has been granted.
3. Central Otago District Council does not provide loan monies. All applicants will be treated as applicants for a subsidy, with the applicant meeting a significant share of the cost of the project.
