TO WHOM IT MAY CONCERN

The Central Otago District Council has received an application from M N and L M Shaw; the application seeks to a subdivision consent to undertake a two lot subdivision of two parent lots, legally described as Lot 1 DP 474100, held in Record of Title 649764 and Lot 2 DP 508107, held in Record of Title 772768 and to cancel a consent notice relating to a parent lot (for the purposes only of clarifying the lots in which it relates).

Proposed Lot 1 will be 2.16 ha. This lot incorporates an area of terrace tread not covered by the existing pivot irrigation system. There is no existing built form on this proposed lot. Proposed Lot 2 will be 32.1 ha. This lot will be retained by the applicants and continue to be farmed under the pivot irrigation system. There is an existing dwelling on this lot. The lot includes the Right of Way access from Chinaman's Gully. The site is located in the Rural Resource Area with an Outstanding Natural feature overlay.

The application requires consent as a discretionary activity in accordance with Rule 4.7.4 (iii) (b) and Rules 4.7.6 L (1) (e) and 4.7.4 (i) for subdivision of land within an Outstanding Natural Feature (ONF). The application also requires a discretionary activity resource consent pursuant to Section 221(3) of the RMA for the cancellation of a consent notice.

The application includes an assessment of environmental effects.
