

Jane&Noel Barrett Notified Application Submission

Our property 67 Clutha RD Ettrick is located 313m to the west of proposed mine site less than 200m to the edge of the mine boundary as shown from the CODC GIS map.

The noise effects are not less than minor particularly as it will be 12 hrs daily 5 days a week 6 months or more. Will the decimal level be monitored ?.

The noise produced by the proposed mine is identified that our property is in the 45 decimal level of the mine site as shown in the Hegley acoustic report.

We are concerned the noise level will reduce the value of our property and be constant irritant .
