
Letter of support for submission on notified resource consent application number 230325.

The current rhetoric stigmatizing the extracting industry by the CODC, and its planners is not conducive of fair and reasonable outcomes for applications such as this and only leads to increased costs which eventually adds to New Zealand's cost of living crisis.
