This Deed made the twelfth day of June  
One thousand eight hundred and seventy five Between Jefse  
Joseph Barker of Cromwell in the Province of Otago and Colony of  
New Zealand Miner and James Alexander Graham of  
Cromwell aforesaid Miner (hereinafter called "the Assignors") of the one  
part and The Corporation of the Town of Cromwell in the said  
Province (hereinafter called "the Corporation") of the other part Whereas  
by the "Municipal Corporations Waterworks Act 1872" in which act the  
"Lands Clauses Consolidation Act 1863" is incorporated and the "Cromwell  
Waterworks Empowering Ordinance 1873" the Corporation is empowered to  
make and purchase for the purposes of the undertaking and works hereby  
authorised the Water Races and other rights intended to be hereby assigned  
and transferred And whereas the Corporation has agreed with the  
Assignors for the absolute purchase of the said Water Races and other  
rights at the price of Seven hundred Pounds which sum is to include  
and be in full compensation for all rights and privileges held enjoyed  
possessed by or vested in the Assignors to the use of the water running in  
Firewood Creek hereinafter mentioned or any of its tributaries **Item 1** This  
Deed witnesseth that in pursuance of the said Agreement and in  
consideration of the sum of Seven hundred Pounds to the Assignors paid  
by the Corporation on or before the execution of these presents (the receipt  
whereof is hereby acknowledged) The Assignors do and each of them  
doth hereby assign and transfer unto the Corporation their successors and  
assigns **Item 2** Water Race three miles in length commencing three  
miles east of Cromwell in Firewood Creek about two miles from its  
junction with the Clutha River and terminating on the east bank of the  
Clutha River half a mile below Cromwell at Harkers Beach for two sluice  
heads of water priority 6293 dated 27 March 1865 and Certificate 10900  
dated District of Dunstan 7 April 1866 last renewal 2243 dated at  
Cromwell 11 July 1874 Also All that Water Race two and a half  
miles in length commencing two miles east of Cromwell in Firewood Creek  
one quarter of a mile below head of before mentioned race and terminating  
at Harkers Beach aforesaid for two sluice heads of water priority 00994  
and 6313 the latter dated District of Dunstan 21 April 1865 last renewal  
2244 dated at Cromwell 11 July 1874 Also All that Dam for tanning  
purposes situated at Dead Horse Flat Harkers Beach granted by Certificate  
1963 dated District of Cromwell 19 July 1867 Also All that Dam for  
situate in Dead Horse Flat aforesaid granted by Certificate 3530 dated  
Cromwell 10 April 1874 Also All that Dam situated at Harkers  
Beach aforesaid evidenced by Certificate 1860 dated District of Dunstan  
4 March 1864 And also All extensions Deviations and Alterations in  
the said properties or any of them And all such estate right title and  
interest in and to the same and every part thereof as the Assignors are or  
shall become seized or possessed of or are by the said Municipal Corporations

Waterworks Act 1872 or by the Act therein incorporated or some or one of them empowered to assign **To Hold** the said premises to the Corporation their successors and assigns according to the true intent and meaning of the said Municipal Corporations Waterworks Act 1872 **Third** the Assignors do hereby for themselves their heirs executors and administrators and each of them doth hereby for himself his heirs executors and administrators covenant with the Corporation its successors and assigns That notwithstanding any act deed or thing by the Assignors or either of them done or executed or knowingly suffered to the contrary the hereinbefore described Certificates Renewals and Licenses are now severally and respectively good and effectual Certificates Renewals and Licenses in the law of the Races rights and premises hereby assigned or expressed so to be and have not nor have any or either of them been forfeited or abandoned or become void or voidable And that the conditions by and in the said Certificates Renewals and Licenses contained or implied have on the Assignors part been duly observed and performed up to the date of these presents And that notwithstanding any such act deed or thing as aforesaid they the Assignors now have and each of them for himself hath good right to assign the said Certificates Renewals Licenses and premises unto the Corporation its successors and assigns in manner aforesaid And that the Corporation its successors and assigns shall and may at all times hereafter peaceably and quietly possess and enjoy the said premises and receive the rents and profits thereof without any lawful eviction claim or demand whatsoever from or by the Assignors their executors or administrators or any person or persons lawfully or equitably claiming from under or in trust for them or any or either of them And that free from all incumbrances whatsoever made occasioned or suffered by the Assignors or either of them their or his executors or administrators or by any person or persons lawfully or equitably claiming as aforesaid And further that the Assignors their executors and administrators and all persons having or lawfully or equitably claiming any estate or interest in the said premises or any part thereof from under or in trust for the Assignors their executors or administrators shall and will from time to time and at all times hereafter at the request and cost of the Corporation its successors and assigns do and execute or cause to be done and executed all such acts deeds and things whatsoever for further and more perfectly assuring the said premises unto the Corporation its successors and assigns as shall or may be reasonably required **In witness** whereof the Assignors have hereunto set their hands and seals and the Corporation have hereunto caused its common seal to be affixed the day and year first before written
