## **Applicant: Mac Gardner**

#### Description of activity:

The applicant seeks to undertake a two lot subdivision with two residential building platforms and QEII covenant area at 41 Totara Place, Queensberry. The subject site is legally described as Lot 17 DP 328097, held in Record of Title 114458, and comprises an area of 8.0440ha more or less. The subdivision will have an average lot size of 4.02ha and will be configured as follows: Lot 1 - 2.7228ha and Lot 2 - 5.3212ha. The residential building platform on proposed Lot 1 will consist of an area of 700m2 in area and the residential building platform on Lot 2 will consist of an area of 625m2. A stone cottage is to be relocated from Lot 1 to Lot 2 outside of the building platform area. Approximately 5ha of the site will be volunteered as QEII covenanted land. The site is located within the Rural Resource Area and the proposal is a non-complying activity pursuant to Rule 4.7.5(iii) of the Central Otago District Plan.

#### Description of activity:

The application seeks land use consent to establish a residential activity and to vary a consent notice. The subject site is located at 3204 Luggate-Cromwell Road, Queensberry and legally described as Lot 1 DP 353628 held in record of title 219147 and is contained within the Rural Resource Area. The proposed residential activity is contained within a building with a maximum height of 8m above ground level and a footprint of 764m2. The site is subject to consent notice conditions including limiting residential buildings to a designated building platform, limiting the maximum footprint of dwellings to 400m2, their height to 5m above ground level, limiting the location of other non-residential buildings to the lower parts of the site, restricting exterior colours and materials and providing standards for the provision of access and services.
