FINAL REPRESENTATION ARRANGEMENTS 2019 LOCAL ELECTIONS

On 30 August 2018 Central Otago District Council gave public notice of its final proposal for representation arrangements to apply for the Council and its community boards for the elections to be held on 12 October 2019. Notification of the right to appeal or object was also given. No appeals or objections were received in respect of the resolution, therefore the representation arrangements for the Central Otago District Council's 2019 local elections will be the same as in the final proposal:

Council Representation

The Council will comprise 11 members elected from four wards, and the mayor.

The four wards reflect the following identified communities of interest:

WARD	COMMUNITIES OF INTEREST
Cromwell Ward	Comprising the area delineated on SO Plan 24243 deposited with Land Information New Zealand.
Maniototo Ward	Comprising the area delineated on SO Plan 24247 deposited with Land Information New Zealand.
Teviot Valley Ward	Comprising the area delineated on SO Plan 24244 deposited with Land Information New Zealand.
Vincent Ward	Being an amalgamation of the Earnsclough-Manuherikia Ward and Alexandra Ward, comprising the areas delineated on SO Plan 386670 and SO Plan 24246 deposited with Land Information New Zealand.

The population that each member will represent is as follows:

Cromwell Ward	7,210	4	1,803
Maniototo Ward	1,780	1	1,780
Teviot Valley Ward	1,710	1	1,710
Vincent Ward	9,600	5	1,920

In accordance with section 19V(2) of the Local Electoral Act 2001 the population that each member represents must be within the range of 1,845 +/- 10% (2,029 to 1,660), unless particular community of interest considerations justify otherwise.

Community Board Representation

Four community boards will be elected. The four community boards will be:

WARD	AREA OF COMMUNITY
Cromwell Community Board	Comprising the area of the Cromwell Ward
Maniototo Community Board	Comprising the area of the Maniototo Ward
Teviot Valley Community Board	Comprising the area of the Teviot Valley Ward
Vincent Community Board	Comprising the area of the Vincent Ward, being an amalgamation of the Earnsclough-Manuherikia and the Alexandra Wards

The Boards will each elect four members. They will not be subdivided for electoral purposes.

The Maniototo and Teviot Valley Boards will each have one appointed member appointed respectively from the Maniototo Ward and Teviot Valley Ward. The Cromwell and Vincent Boards will each have three appointed members, appointed respectively from the Cromwell Ward and the Vincent Ward.
